Terms and Condition

Nordic Terrain Academy A.S. (Stavanger, Norway)

Camper's Commitment

All campers agree to the following:

1. To act in a courteous, considerate and responsible manner with respect for all members of Nordic Terrain Academy (NTA); campers, counselors, camp staff, instructors and members of the public in Norway.
2. Communicate directly and clearly with the NTA staff regarding any concerns or questions that may arise during camp.
3. Not to leave campus without permission or alone without a member of NTA accompanying.
4. Not to enter any other campers' room without permission and never to enter the room of a camper of the opposite gender.
5. Not to consume alcohol, tobacco or any other illegal substance within the Norwegian laws during the entire time at NTA.
6. Behave in a responsible manner and comply with all Norwegian laws and regulations.
7. Be aware and follow all camp rules and be aware of all risks and hazards to ensure safety.
8. Be punctual to all activities, prepared for all weather conditions and act with safety in mind.

Camper dismissal

NTA reserves the right, during camp, to send any child home or to his/her guardians, if in the opinion of NTA the child is incompatible with the general well-being of the camp through his/her negligence of camp rules and regulations. In such circumstances, no refund will be provided and the parent/guardian will be liable for any travel or related expenses incurred due to dismissal.

Campers Health and fitness

Parents/Guardians have reviewed the NTA program and certified that their son/daughter is physically and mentally capable of participating in the NTA program. Any medical physical or mental illness, diagnoses, condition or concerns have been disclosed to NTA directors. NTA reserves the right to withdraw a camper's acceptance if, NTA feels that they would be unable to participate and enjoy the full NTA program.

Medical Treatment

By their signature on NTA Terms and Conditions, parents or legal guardians authorize NTA to take whatever action deemed necessary to secure medical treatment for the child at the parents' or legal guardian's expense.

Camper insurance

Campers must have full travel insurance coverage for the entire duration of their travel and participation at NTA, including full medical, accident and potential liability to third parties insurance valid in Norway. The camper must bring proof of such insurance with them to the camp and parents/guardians must send an electronic proof prior to arrival in Norway.

Events beyond Nordic Terrain Academy's control and adverse weather conditions

- a) Reimbursements will be made on a case-by-case basis for late arrival or early departures. All reimbursements must be made in writing by a director of NTA.
- b) If, determined by NTA that conditions are hazardous to determinantal to the objectives of the program due to adverse weather, activities may be altered or canceled. If activities are canceled NTA will make every effort to reschedule or find alternative activities that meet the needs of the program. No reimbursement will be made because of canceled activities for any reason.

Cancellation Policy

- a) Any cancellations received prior to 30 days before the start of the camp, will receive a 50% refund, upon writing request to NTA director: morgan@nordicadventure.camp. Deposit is not included in the refund.
- b) No refund will be provided 30 days or less before camp or once camp has started.

Promotional Material

NTA reserves the right to take photographs or video during the camp sessions to be used only for promotional purposes including but not limited to: daily photo galleries, website, program brochures, advertisements and for use by NTA agents to promote the program. No names will be used except for testimonials and permission will be requested in writing by a camp director.

Liability

NTA accepts no liability for an additional expense, distress, disappointment, loss, damage, injury, accident, delay or inconvenience resulting from or attributable to the act or default of any company, firm or persons in connection with the carrying out of such arrangements or booking or the convenience of any clients. Every booking is accepted subject to the conditions imposed by these outside companies or agencies and any claim with respect to such matters must be made against the appropriate principal. NTA will make every effort to support should any actions be needed.

Parent responsibilities

Parents or guardians accept full financial responsibility for the following reasons, for anyone they register in NTA programs:

- a) Damage caused, whether willful or not to facilities, equipment, clothing or anything belonging to or leased by NTA.
- b) Repatriation expenses for any person having to be sent home or to a designated place, due to illness, accident, misbehavior or any other reason deemed valid by NTA.
- c) Any pocket money or any purchase of a personal nature made on behalf of the child for anything not expressly included in the camp package.
- d) Rental or purchase of any equipment deemed essential for a child to enjoy his/her experience due to their own equipment being unfit, unsafe or missing.

Compassion Policy

Changes to NTA policies may be amended if accepted in writing by the President of NTA due to hardships of our camper or camper's family.

General commitments

- a) English is the spoken language at camp. Although we encourage students to use a second and third language along with their mother tongue, due to safety, proficient English is a per-requisite.
- b) All prescription or non-prescription medicine must be turned into the camp staff upon arrival with instruction in English unless prior agreements have been accepted in writing by an NTA director.
- c) All parents are required to read and explain to their children the set of rules encompassed within the "Parent's Handbook" that shall be emailed to them before the start of the program.
- d) Children maintaining the highest standard of conduct is required at all times. Using profanity, disparaging dialogues, physical violence or threats during participation at NTA is strictly prohibited. Camp rules and instructions of Nordic Terrain Academy counselors and staff must be followed at all times.
- e) By accepting these Terms and Conditions, the parent confirms that his/her child has permission to participate in all camp programs, camp trips, special outings planned and supervised by NTA.
- f) All your child's personal belongings are their own responsibility, unless loss or damage is proven to be due to NTA negligence. Expensive and treasured items such as jewelry, designer clothes or shoes, trainers, etc., should not be brought to the camp.
- g) Parents agree to support the NTA program by encouraging children to abide by the highest standards of positive conduct. They will discuss constructive concerns, if any, regarding the NTA program, counselor or staff behavior or company policies with NTA management.
- h) Parents agree to pay for property damage caused directly, or indirectly, as a result of negligent action of their child.
- i) All flight information should be shared with NTA (if applicable) when booked to arrange pick up and drop off. Campers are expected to arrive on the first day and program and depart on the last day. Accommodation and activities can be arranged at an additional cost.
